

KIM'S GUN SHOW SAFETY RULES & POLICIES

KIM'S GUN SHOW PROVIDES A SAFE, LEGAL, AND CONVENIENT OPPORTUNITY TO BUY/SELL/TRADE GUNS, KNIVES, AMMO, MILITARY COLLECTABLES, COINS, AND RELATIVE ITEMS. BY SIGNING THIS AGREEMENT, YOU AGREE TO OBEY ALL FEDERAL, STATE, LOCAL LAWS AND WILL ABIDE BY ALL OF KIM'S GUN SHOW SAFETY RULES & POLICIES. GUN SAFETY RULES MUST BE FOLLOWED AT ALL TIMES. VIOLATORS ARE SUBJECT TO EVICTION FROM THE GUN SHOW WITHOUT ANY MONITARY REFUND.

ALL GUNS MUST BE SECURED BY TIES THROUGH THE TRIGGER GUARD OR THE BOLT MUST BE REMOVED FOR THE DURATION OF THE GUN SHOW AND WHILE AT THE AUSTIN HWY EVENT CENTER. THIS INCLUDES PERSONAL WEAPONS. EXHIBITORS ARE RESPONSIBLE FOR THE SECURITY OF THE ITEMS THEY DISPLAY.

ALL FIREARMS BROUGHT TO THE SHOW BY THE PUBLIC WILL BE INSPECTED AND SECURED BY SECURITY OFFICER PRIOR TO BEING ADMITTED TO THE SHOW.

- NO LOADED FIREARMS
- NO EXPLOSIVES ARE PERMITTED OTHER THAN SMALL ARMS AMMO, GUN POWDER AND PRIMERS IN SEALED CONTAINERS
- NO LOOSE AMMUNITION
- NO LOADED MAGAZINES
- NO ALCOHOL OR DRUG USE

GUN SHOW SECURITY IS PROVIDED BY LOCAL LAW ENFORCEMENT IN UNIFORM AND PLAIN CLOTHES. VENDORS ARE STILL RESPONSIBLE FOR SAFE GUARDING THEIR OWN TABLES AND MERCHANDISE FROM THEFT.

REQUIRE PROPER IDENTIFICATION WHEN SELLING FIREARMS OR AMMO. YOU MUST BE 21 YEARS OLD AND A TEXAS RESIDENT TO BUY A HANDGUN OR HANDGUN AMMO. MINORS ARE NOT PERMITTED IN THE SHOW WITHOUT PARENTS.

FOR SECURITY AND SAFETY PURPOSES THE BACK DOORS OF THE VENUE WILL REMAIN **CLOSED** DURING AND UNTIL THE END OF THE SHOW ON SATURDAY AND SUNDAY. SECURITY OFFICIER WILL OPEN REAR DOORS AT THE END OF THE GUN SHOW.

PARTICIPATION FOR THE **ENTIRE** SHOW IS EXPECTED OF ALL VENDORS. LEAVING THE SHOW EARLY MAY RESULT IN LOSS OF PRIVILEGE TO PARTICIPATE IN FUTURE SHOWS.

PAYMENT NEEDS TO BE RECEIVED BY 4PM ON SUNDAY TO SECURE YOUR SAME PLACEMENT IN THE SHOW EVERY MONTH. TABLE LOCATIONS ARE NOT GUARANTEED WITHOUT PAYMENT.

NO REFUNDS WILL BE GIVEN FOR CANCELLATIONS 10 DAYS PRIOR TO THE NEXT SHOW.

VENDOR BADGES MUST BE WORN DURING THE SHOW

THE GUN SHOW PROMOTER AND THE AUSTIN HWY EVENT CENTER ACCEPTS NO RESPONSIBILITY OR LIABILITY FOR ANY AND ALL DAMAGES OR INJURIES RESULTING FROM AN EXHIBITOR'S OR PATRON'S DISPLAY OR ACTIONS. EXHIBITORS AND PATRONS HEREBY ASSUME FULL LIABILITY FOR ANY AND ALL DAMAGES OR PERSONAL INJURIES RESULTING FROM THE USE OF ANY ITEM OF THE EXHIBITOR OR PATRON AND WILL HOLD HARMLESS THE GUN SHOW PROMOTER. THE GUN SHOW PROMOTER RESERVES THE RIGHT TO REFUSE ADMISSION TO ANYONE. VIOLATION OF THESE RULES BY A PATRON OR EXHIBITOR MAY RESULT IN DISMISSAL FROM THE GUN SHOW.
